Thanks to everyone who attended the annual membership meeting at the Clubhouse on February 22nd. In addition to voting for new Board members, we gave well deserved thanks to outgoing Board members **Mike McCarthy, Tom McCullough** and our former President, **Mike Miller**. I would also like to give a special thanks to Mike Miller for his leadership and dedication. Mike worked tirelessly at the club doing many things that go unseen, but are essential to the operations and enjoyment of the club. Believe me when I say that we have been extremely fortunate to have had someone that cared so much about the club. We are also fortunate to have three equally qualified new Board members, **Dan Gretz, Dorothy Flint, and Ted Conroy**, who will immediately begin serving their three-year terms. Since the annual meeting, we were all saddened to learn that due to work commitments **Pat Hyland** has decided to step down from the board. Pat has spent a year on the board and his services are greatly appreciated. Please welcome **Tom Trainor**, one of the 4 people running this past election, who the Board has appointed to replace Pat.

A quorum was present at the annual meeting and a vote on the amended Budget was held and passed. A copy of the amended budget is attached. One of the measures approved in the Budget is for a new parking lot, which will be in place for the start of the season and will be a great improvement for the club.

As was mentioned in our last mailing and at the annual meeting, Lighthouse Pool Management will once again be our pool management company this year. They have already begun staffing for the 2011 season. Information regarding the Swim, Dive and Tennis programs will be sent in early May and will also be posted on the website.

Enclosed with this letter is your **Annual Membership Dues Invoice**. **Please note that the Board voted to keep this year's dues the same as last year.** It is required for admittance to the club that each member acknowledge the club's liability policy by completing and signing the enclosed form, and return it with your **annual dues payment by April 16, 2011.**

As a reminder, only those family members who are permanent members of your home should be listed on your membership. Childcare providers, including nannies or au pairs, are not included under the family membership. You may purchase a seasonal pass for your childcare provider for \$55.00. Please see the website, or contact the office, to receive the childcare provider application form. There will be no price increase for guest passes. Consistent with prior years, we are offering seasonal guest passes (good for 10 visits) at a reduced pre-season rate of \$25.00 which can be purchased when dues are paid by April 16, 2011.

This year, we are planning our **Spring Clean-Up Day** on **Saturday, May 14th** (with a rain date of **Sunday, May 15th**). Clean up will begin at 9:00 AM and last until 2:00 PM, so come out and lend a hand as the volunteer hours that our members contribute help keep our costs down and the facility looking beautiful.
